→ Approved cardboard boxes

Combination packaging is approved for the transfer of dangerous and/or regulated goods by air, road and sea. It provides safe shipment of liquid or solid products of all classes in accordance with current regulations (IATA, ADR, IMDG, RID) (except 6.2 and 7 – please contact us for further information).

4G and 4GV approved boxes

We have a complete range of 4GV approved cardboard packaging which is, by definition, suitable for all groups of hazardous products.

They can be combined with an isothermal PU barrier for shipping hazardous materials at controlled temperatures.

- Assemble in 2 minutes
- Complies with current regulations (IATA, IMDG, RID and ADR).
- All references are 4GV approved, allowing the use of all types of inner containers or solid objects.
- Must be used with an absorbent (i.e. vermiculite).
